You must use the Vocational Scholarship Application form. It must be dated and signed by you and your parent(s) or guardian. Typewritten applications are preferred over handwritten submissions. Applications and all supporting documents must be in English or English translations.

**Employment**

List jobs held and community service performed from November 1, 2018, through the current date. Please list total hours worked, not average hours per week. You will receive 0 points in this section if you do not list your hours as instructed.

**Custodial Parent**

If your parents are divorced or separated, answer the questions for the parent you lived with the most in the past 12 months. If you lived with both parents an equal number of days in the past 12 months, you would count the parent who provided you with the greatest amount of support, financial as well as material.

Material things would include cars, clothing, medical and dental payments, etc. If that parent has remarried, you must include that stepparent's information. Note: If the family has divorced or separated within the past five years and the custodial parent has not remarried, you must provide the financial information of the non-custodial parent.

**Independent Student**
